

As an Automotive Technology student at Penta, Tom Berkebile was unlike most of his fellow classmates. Instead of enjoying the engine repair aspect of the automotive program, Tom preferred learning about and working on the electrical systems of vehicles.

“Penta helped prepare me for my current career as an electrical systems engineer,” says Tom. “Because of the firm understanding of the fundamentals I learned at Penta, I’m a rare find in Detroit. I know complete vehicles bumper-to-bumper and I understand the effects of one system on another.”

In 1985, Tom continued to pursue his interest in electronics when he joined the United States Army. Tom studied electronics at a satellite ground receiving station while in the service. He served in Landstuhl, Germany for four years.

When Tom was discharged from the service, he returned to the Toledo area and worked for a few years for a copier company. At the same time he began taking classes at The University of Toledo toward a bachelor’s degree in electrical engineering technology.

While still in college in 1992, Tom was hired by the Ford Motor Company as an electrical systems technician where he was responsible for many functions including technical support and creating truck prototype CAD drawings of vehicle electronic/electrical systems. His experiences at Ford also included managing the EESE breadboard lab facilities and testing and prototyping electrical/electronic truck systems.

In 1998, Tom became an EDS systems engineer at Alcoa-Fujikura, LTD in Allen Park, Michigan where he worked as the lead engineer on the electrical distribution systems for vehicles such as the 1999-2001 Lincoln Navigator/Ford Expedition and the 2002 Lincoln Blackwood.

Tom’s success at Alcoa, provided him the opportunity to advance to his dream job. In 2000, Tom accepted an engineering position at Magna International in the company’s Intier Automotive Interiors Division located in Novi, Michigan. Magna, the most diversified automotive supplier in the world, designs, develops and manufactures automotive systems for sale to original equipment manufacturers (OEMs) of cars and light trucks in North America, Asia and South America.

In just six short years at Magna, Tom has accomplished a great deal. He has been the lead electronic/electrical systems and program engineer for the Ford power running board system. Tom was issued a patent from the United States Patent and Trademark Office in 2005 for his work on the pneumatic version for the power running board system.

Due to his busy career, Tom barely has time for relaxation. When he does have spare time, he enjoys radio-controlled airplanes, downhill skiing (he has skied in the Alps), and home repair projects. Tom lives in Perrysburg with his wife, Lisa Hoverson. He has a son, Austin and stepchildren, John and Amanda.




